Feedback from staying in HDB flats near TPE

Please refer to your email dated 9 Aug 2010 which was referred to HDB by the Pasir Ris

2 Firstly, we would like to apologise for the delay in our reply as we need to consult our relevant technical department.

3 We wish to share that all buildings are subject to URA's setback guidelines. For buildings near expressways, the minimum setback required is 30 metres and it varies for different categories of roads.

4 The actual distance from Blk 117 Edgefield Plains to TPE is almost 60 metres (setback is almost double the minimum requirement). In addition, HDB had designed the housing precinct such that the multi storey carpark Blk 119 Edgefield Plains is facing the traffic from the expressway (TPE), which helps to serve as a physical barriers.

5 Based on your email, we understand that you had purchased your current flat from the open market several months ago and therefore, it is understandable that your family may need time to adjust to your current living environment. We sincerely hope that you and your family will be able to settle in and develop good neighbourly ties with your neighbours in the near future.
