ANNOYING/HORRIBLE TRAFFIC NOISE FROM VEHICLES ON TAMPINES EXPRESSWAY(TPE)

FEEDBACK NUMBER: 20100809-0032

We refer to your email of 8 August 2010.

We noted your concern on the traffic noise from the Tampines Expressway (TPE). We seek your understanding that in land-scarce Singapore and in view of our highly urbanised settings , building of roads and expressways close to residential areas cannot be totally avoided . As a result, some degree of traffic noise is inevitable. There is a multi-agency effort involving the National Environment Agency (NEA), Land Transport Authority (LTA), Traffic Police (TP), Urban Redevelopment Authority (URA) and Housing and Development Board (HDB) that explores measures to minimise the impact of road traffic noise on residents living along expressways and roads. The LTA, URA and HDB have been implementing cost-effective measures to alleviate road traffic noise pollution such as :

- a) Using noise-absorptive porous asphalt material for road surfacing .
- b) Setting back new residential buildings from expressways .
- c) Siting industrial buildings , recreational facilities and parks to be located next to expressways and major arterial roads to act as noise shields to residential buildings at the planning stage .

We have also explored the feasibility of building noise barriers . However, their effectiveness is limited, especially for the upper floors of high-rise buildings. In view that you have forwarded your feedback to the various agencies, we trust that they have also noted your concerns.

Once again, we seek your understanding and thank you for your feedback.
